### PETITION TO AMEND CC&Rs

Pursuant to Civil Code Section 4275, Vista La Jolla Townhome's legal counsel, Epsten Grinnell & Howell, is preparing a petition to seek approval by the court, of an amendment to the CC&Rs, lowering the approval amount



for future amendments and updating lender approval requirements. Section 4275 provides a way for Associations that have a supermajority approval for amendment of their CC&Rs to petition the

court for approval of an amendment when it failed to achieve a super-majority requirement. An Association may file a petition when it has held a proper vote on the amendment and has achieved approval of at least a majority of the homeowners (50%).

Your declaration currently requires a 75% vote of all members. That means that anyone who does not vote is effectively a negative vote. Under this petition for the revision, an amendment will require a simple majority of members.

## Help Stop Solicitors

Help us keep solicitors out of our community. Solicitors can cause an annoyance by littering the ground, mailboxes, and front doors with flyers. Not only can they be irritating, but they can cause homeowners to feel uncomfortable by becoming overly pushy and aggressive.

<u>Parkíng</u> <u>Remínders</u>

Parking can be an issue within our community. To help ease this situation, Management is asking all residents to review the rules regarding parking.



• Garages must be utilized for parking two vehicles.

• Parking boats, trailers, and motor homes are prohibited on all streets.

• Guests must park in designated guest spaces and at raised curbs

- Always allow a twenty-foot driving lane between parked vehicles when parking.
- Blocking any driveway, garage, or sidewalk is in direct violation of the City ordinance.
- Red curbs are Fire Lanes, blocking them can result in towing and fines from the City.
- Parking facing the wrong way is against the law and prohibited.

<u>\*Violating any of the above parking</u> <u>rules may result in a violation or</u> <u>hearing notice, and your car can be</u> <u>towed. If you are called to a hearing,</u> you may be fined.\*
