

## **Pool Policy Reminders**



With Summer here, it's time to splash and play in the water. In order to keep everyone safe & ensure that all residents can enjoy this amenity, Management would like to remind all residents of the following Rules and Regulations:

- No lifeguard is ever on duty. Swim at your own risk.
- Replace spa covers after every use.
- All children less than 14 years of age must be under the direct supervision of a responsible resident who is 18 years of age or older.
- Climbing the pool enclosure, and all running and diving in and around the pool is prohibited.
- Bicycles, tricycles, skateboards, roller skates, and in-line skates are not allowed.
- No pets are permitted.
- Glass containers or objects are strictly prohibited.
- Residents and guests must deposit all trash in trash receptacles, or collect and dispose of trash at their living units.
- Littering the pool area is not permitted.
- Residents and guests are to provide their own towels for use in the pool areas. No one is allowed to remove pool furniture from the pool areas.
